Dues \$30

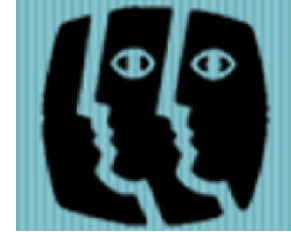
